- **a.** The Managing Director, TNFDC Ltd, a Government of Tamil Nadu Undertaking, is inviting "EOI" for the appointment of vendor for running a retail fish outlet either permanent or mobile retail outlet under franchisee model.
- b. The "Expression of Interest" (EOI) documents may be downloaded through internet from <a href="www.fisheries.tn.gov.in">www.tnfdc.in</a> / <a href="www.tnfdc.in">www.tnfdc.in</a> / <a href="www.meengal.com">www.meengal.com</a> at free of cost.
- C. The applicants shall submit their online application through "KAYAL" portal at <a href="https://kayal.tnfdc.in/">https://kayal.tnfdc.in/</a> on payment of application fee of Rs.100.
- d. The online applications shall be printed and submitted along with all necessary documents and confirmation of fee payment to the Managing Director, TAMIL NADU FISHERIES DEVELOPMENT CORPORATION LIMITED, Integrated Office Complex for Animal Husbandry & Fisheries Department, No.571, 4th Floor, Anna Salai, Nandanam, Chennai 600035. The cover should be superscribed as "Appointment of vendor for running a retail fish outlet either permanent or mobile retail outlet under franchisee model".
- e. While submitting EOI, the applicant should certify that they have read & fully understood and abide by the "terms and conditions" and TOR.
- f. The received EOI will be opened by the designated committee at office of the Managing Director, TNFDC Ltd., Chennai-35 and processed on 5th day of every month.
- g. The successful applicants will be enlisted in the list of appointed vendors and intimated through available channels communications on or before 10th day of every month

#### MINIMUM ELIGIBILTY CRITERIA PRESCRIBED FOR QUALIFICATION

- i. Experienced qualified individuals, members of Fishermen Cooperative Societies, Fishermen/ Women Cooperative Societies, vendors, firms, companies, Fishermen Fish Producer Organizations (FFPO) having suitable potential, financial and managerial capabilities should submit their application for Appointment of Vendor for running a Permanent or Mobile Retail Fish Outlet under franchise model with the details as listed in this document.
- ii. Preference will be given to the Fisherwomen/ Fishermen Cooperative Societies / FFPO's/ JLG's / members of Fishermen Welfare Board, Fishermen Fish Producer Organizations (FFPO)
- iii. Previous Experience in the fish and fishery products trade is desirable.
- iv. Balance sheet in case of firms/companies with IT returns of previous 2 years.
- v. Turnover details in case of firms/ companies for last 2 years.
- vi. Aadhaar, PAN Number, GST Certificate (if applicable).
- vii. Should posses a land or shop of appropriate size either on lease or own.

#### **VALIDITY OF EOI:**

- i. This is a Rolling EOI for the appointment and TNFDC reserves the right to terminate the same without any notice.
- ii. The appointment shall be valid for a minimum period of 1 year from the date of acceptance and extendable for further period as decided by the TNFDC Ltd.
- iii. If any information provided by the applicant are found to be factually false or misleading, such proposal will summarily be rejected at any time during the validity of the tender and liable for penalties as applicable.
- iv. The EOI are liable for rejection due to the following reasons:
  - 1. Incomplete / non-submission of any of the documents sought for.
  - 2. For any disqualification made by the TNFDC Ltd and Government of Tamil Nadu for becoming blacklisted
  - 3. Default in the previous transaction.
  - 4. Incomplete technical and commercial bids submissions

v. Violation of any of the terms and conditions of the EOI or the agreement executed by the applicant is liable for stringent actions like forfeiting of security deposit amount and disqualification to participate in departmental tenders for a period of three years or any other punishment as deemed fit in the opinion and judgment of the Government of Tamil Nadu depending on the nature of violation.

#### LEGAL TERMS AND COMPLIANCES:

- a. The successful applicant in EOI for the appointment of vendor for running a retail fish outlet either permanent or mobile retail outlet under franchisee model shall execute an agreement covering the Terms and Conditions of the Tender in Rs.200/-Non-Judicial Stamp Paper or as per the existing procedure at his cost, at the time of acceptance of appointment with TNFDC Ltd.
- b. In respect of any dispute arising out in implementation of this tender, the decision of the Managing Director, TNFDC Ltd/Director of Fisheries and Government of Tamil Nadu shall be final.
- c. For any legal remedies, the Courts at Chennai city shall only have the jurisdiction.

#### OTHER CONDITIONS:

- a. The conditional EOI will be rejected.
- b. The empanelment EOI Accepting Authority reserves the right to reject the tender even after opening of Tenders without assigning any reasons whatsoever.
- c. A pre bid meeting will be organized by the TNFDC on 15<sup>th</sup> day August 2025 at 3.00 pm at the office of TNFDC to clarify doubts if any on the scheme.

#### Terms of Reference (TOR) for the EOI for Appointment of Vendor for running a Permanent or Mobile Retail Fish Outlet under franchise model.

The Tamil Nadu Fisheries Development Corporation Limited is a Government of Tamil Nadu undertaking carrying out retail fish marketing activities in Chennai City and running modern retail outlets and mobile fish marketing kiosks at various places in Chennai, Coimbatore and sub- urban areas surrounding these places.

The TNFDC Marketing units are purchasing around 400 MT of Marine fishes annually from wholesale fish merchants and fishermen from fishing villages and around 200MT of Inland Fishes from Inland water bodies especially in Coimbatore and Tiruppur Districts and selling it its consumers.

The probable varieties of marine and fresh water fishes being purchased by the Marketing Units based on the size, weight etc., are given in annexure-I for reference.

## Objective for appointment of fish vendors under franchise model:-

The TNFDC, intends to expand its retail fish marketing units and desires to appoint the potential Vendor for running a Permanent or Mobile Retail Fish Outlet under franchise model from Chennai City and other places of Tamil Nadu for operating retail units of fishes.

### Process of appointment and Scope of the works of fish vendors under franchise model:-

- 1. The applicants shall submit their online application through "KAYAL" portal at https://kayal.tnfdc.in/ on payment of application fee of Rs.100.
- 2. The online applications shall be printed and submitted along with all necessary documents and confirmation of fee payment to the Managing Director, TAMIL NADU FISHERIES DEVELOPMENT CORPORATION LIMITED, Integrated Office Complex for Animal Husbandry & Fisheries Department, No.571, 4th Floor, Anna Salai, Nandanam, Chennai 600035. The cover should be superscribed as "appointment of vendor for running a retail fish outlet either permanent or mobile retail outlet under franchisee model".

- 3. While submitting EOI, the applicant should certify that they have read & fully understood the "terms and conditions" and TOR they will abide by the same.
- 4. The received EOI will be opened at office of the Managing Director, TNFDC Ltd., Chennai-35 and processed by a designated committee on 5th day of every month.
- 5. The successful applicants will be intimated through available channels of communication and enlisted in the list of appointed vendors on or before 10th day of every month
- 6. Filled in application long with ID Proof, Address Proof, Aadhar Details, Bank Statement and Photo of the Individual will be scrutinized by the Committee nominated by the Managing Director, TNFDC Ltd. Preference will be given to the Fisherwomen/ Fishermen Cooperative Societies / FFPO's/JLG's
- 7. The space /shop (not less than 150 Sq.ft.) owned/leased by the applicant will be inspected for its suitability as regards to the Water Supply, Drainage, Approach to the Customer, etc. For mobile outlet the vehicle should be similar to that of one being used by TNFDC Ltd.
- 8. On ascertaining the suitability of the shop / vehicle owned/leased by the applicant provisional selection will be made by the TNFDC.
- 9. In the case of property on lease, the applicant may enter into an agreement with the owner of the property in his name and the rent for the shop/ vehicle so identified and shop established may be paid by the Franchisee to the land owner after the provisional selection by the TNFDC.
- 10.In case of multiple applications for a single location, the appointment will be made based on the suitability of the shop / vehicle owned/leased by the applicant and marketing potential of the location as decided by the committee.
- 11.Based on the provisional selection of the individual and his/her identified shop or mobile outlet, provisional appointment as Franchise Retail Fish Outlet will be issued by TNFDC Ltd.
- 12. The Franchise has to appoint necessary supporting staff such as Sales Assistant, Helper, Cutter as required for carrying out hygienic and smooth sales.

- 13.On receipt of the provisional selection, the applicant shall deposit refundable Security Deposit of Rs.50,000/- in the form of DD with TNFDC which does not bear any interest.
- 14. The fish required / intended by the Franchisee through a system implemented by the TNFDC will be supplied to the Franchise by TNFDC. The Franchise is at liberty to use his own transportation means complying with the cold chain requirements of TNFDC or to use the fish transportation vehicles of TNFDC at the specified rates.
- 15. The Franchisee shall ordinarily arrange to take the delivery of the intended fish from the designated distribution Hub on a daily basis only after making advance payment for intended consignment. The fish shall also be delivered at the retail outlets on pre agreed terms and conditions.
- 16. While making the advance payment for the intended consignment, the Franchisee shall deduct a Trade margin @ 5 15% on as may be specified by the competent authority of TNFDC from time to time on the MRP fixed by TNFDC.
- 17.Ice in crushed form will be supplied in the ratio of 1:2 by TNFDC Ltd. Additional ice if required has to be purchased by the Franchisee at the cost specified by the TNFDC.
- 18. The Franchisee has to carry out the sale of value-added fishery products supplied by TNFDC in addition to the fish at a price not exceeding the MRP fixed by TNFDC.
- 19. The maximum retail price (MRP) will be fixed by TNFDC Ltd., on daily basis and products has to be sold by the Franchisee not exceeding the MRP.
- 20. The Franchisee must provide proper bills either in printed or electronic format in the name of TNFDC using of the software application of TNFDC.
- 21. The Stall branding and model shall be as specified by the TNFDC only.
- 22. No spoilage of fish / return will be entertained by TNFDC from the Franchisee once the goods are delivered and accepted by the Franchisee.
- 23. The franchisee shall not all any fish which do not comply with the quality standards of TNFDC. The franchisee shall ensure proper cold chain arrangements through out the value chain.

- 24. The franchisee shall implement all quality standards at the retail out let prescribed by TNFDC
- 25.The minimum sales target of 800-1000 Kg / month in a calendar year is a fixed one. (However, the sales target allowed for 1st Month 750 Kgs. 2nd Month 850 kgs 3rd Month onwards 1000 kgs). The sales target is subject to change based on profit / loss in fish marketing by TNFDC.
- 26.In case of continuous non achievement of target for a period of Three months, TNFDTNFDC reserves the right to initiate action for impose of penalty or termination of the Franchisee after providing opportunity for hearing.
- 27. The Franchisee has to maintain the fish retail outlet in most hygienic manner complying with the SAFE FISH initiative requirements as specified by the TRNFDC along with proper solid waste management without any civic complaints.
- 28. The list of equipment and accessories listed in Annexure has to be provided to the stall by the franchisee at his cost as per branding of TNFDC Ltd.
- 29. The Franchisee has to execute an agreement on non judicial stamp paper with TNFDC Ltd., which is renewable every year.
- 30. The Managing Director, TNFDC Ltd., reserves all rights to accept or reject the application for Franchisee.
- 31.All necessary Statutory Clearances and License to be obtained by the Franchisee from concern authorities.
- 32. There will be surprise checks and inspection from TNFDC Ltd., If any terms & conditions prescribed not followed will result in penalty or termination of licence or both.
- 33. All disputes relating to the franchised retail outlet licence are to the terms and condition above referred to or the interpretation thereof shall be referred to the sole arbitration of the Managing Director, TNFDC Ltd and whose decision shall be final/binding. The arbitration will be conducted under the Arbitration and Conciliation Act. Any civil disputes are only at Chennai city court limits on the dispute arising out of the agreement.
- 34.It is specifically understood that the relationship between the Corporation and the Franchisee is of seller and Buyer and cannot be construed as Employer and Employee.
